POLICY COOKIES

WHAT COOKIES ARE

Cookies are text files and numbers that are installed in the memory of your browser while browsing a website through any device that allows connection to the internet (PC, smartphone or tablet).

Through cookies, natural persons can be associated with online identifiers produced by the devices, applications, tools and protocols they use, examples of cookies are IP addresses, temporary markers or other types of identification. Such identifiers can leave traces which, in particular when combined with unique identifiers and other information received from servers, can be used to create profiles of individuals and identify them.

The information encoded in the cookies may include personal data, such as an IP address, username, unique identifier or email address, but may also contain non-personal data, such as language settings or information about the type of device that a person is using to browse the site.

Cookies can therefore perform important and various functions, including monitoring sessions, storing information on specific configurations regarding users accessing the server, facilitating the use of online content, etc. For example, they can be used to track items in an online shopping cart or information used to fill in a computer form.

Cookies can be stored permanently on the device used for navigation (the so-called "persistent cookies"), until the pre-established expiry date (minutes, days, years), or they can be automatically deleted when the browser is closed (the so-called "session cookies").

Cookies can be installed by the site visited by the user (so-called "first-party cookies"), or they can be installed by other websites (so-called "third-party cookies").

TYPES OF COOKIES AND RELATED PURPOSES

1) Cookies and other technical identifiers (Article 122 c. 1 Legislative Decree 196/03)

These are cookies that allow the transmission of a communication over an electronic communications network, therefore those that allow navigation of the site DO NOT NEED THE USER'S CONSENT

2) First and third party analytics cookies

The first and third party analytics cookies are those used to guarantee and facilitate the activities strictly necessary for the functioning of the Site for the normal navigation of the site and allow its functions (such as allowing, for example, to authenticate to restricted areas, to save the session browsing, browsing preferences, saving products in the cart, remembering some selected criteria such as language, managing the distribution of traffic, etc.) and to collect some information in aggregate (anonymous) form about users. They are comparable to technical cookies (and therefore the USER'S CONSENT is NOT required) only when:

- they are used only to produce aggregate statistics and in relation to a single site or a single mobile application;

- for those of third parties, at least the fourth component of the IP address is masked;

- third parties refrain from combining these analytics cookies with other processing (customer files or statistics of visits to other sites, for example) or from transmitting them to third parties.

3) Profiling cookies and other tracking identifiers with NON-TECHNICAL function

They are used to bring back to specific, identified or identifiable subjects, specific actions or behavioral patterns recurring in the use of the functions offered (groups) in order to group the different profiles within homogeneous clusters of different size, so that it is also possible modulate the provision of the service as well as send targeted advertising messages, i.e consistent with the preferences expressed by the user in the context of surfing the net.

Among these third-party cookies, there are those that allow users to interact with social networks (Facebook, Twitter, YouTube, Vimeo, etc.) and in particular to share site content through the aforementioned channels.

DATA SUBJECTS RIGHTS

As data subject, you have the right to ask to the Data Controller:

- the confirmation, as to whether or not, that your personal data is being processed and, in this case, to obtain access to them (right of access);

- the correction of inaccurate personal data or the integration of incomplete personal data (right of rectification);

- the cancellation of the data, if there is one of the reasons provided for by the Privacy Regulation (right to be forgotten);

- the limitation of processing when one of the hypotheses provided for by the Privacy Regulation occurs (right of limitation);

- to receive the personal data you have provided to the Data Controller in a structured format, commonly used and readable by an automatic device and to transmit such data to another Data Controller (right to portability);

- to object at any time to the processing carried out for the pursuit of a legitimate interest of the owner (right of opposition);

- to revoke any consent to the processing of your data, at any time, without prejudice to the lawfulness of the processing based on the consent given prior to the revocation.
